

System Warranty

TAS Contract offers a limited project-specific System Warranty to their clients on a per-project base. Our System Warranty provides our clients with added security for their project and piece of mind that TAS Contract will be their direct point of contact and partner during the duration of and up to 1 (one) year after the flooring has been installed. This System Warranty will cover the pre-approved flooring contractor used for the installation, that all products used are approved for use together by all manufacturers, as well as the direct point of contact in the process of navigating problems that may occur during and after the installation, within the stated time of the warranty. TAS Contract will navigate the repair and/or replacement process for any material found to be defective by the manufacturer and will assist with the repair or replacement with like product and reasonable labor rates at the discretion of TAS Contract.

This System Warranty is applicable to our client and will be transferrable to the first purchaser of their project, within the first year after the installation of the flooring.

Regarding claims submitted under the System Warranty, TAS Contract reserves the right of inspection and arbitration on behalf of ourselves and our partners. TAS Contract reserves the right to replace or provide corrective actions to the affected area at our discretion, as well as reserve the right to inspect prior to any actions being taken. All claims must be submitted in writing by the subcontractor, following the T&A Supply Company claims process within 1 (one) year after the flooring has been installed and before any corrective actions have been taken.

Requirements for obtaining a System Warranty;

1. Submit a System Warranty Project Request form to TAS Contract team for review
2. Attend a Pre-Construction Meeting with TAS Contract team members
3. Attend a Project Walk/Site Inspection with TAS Contract team prior to flooring system installation
4. Follow all installation instructions provided by the manufacturers of the products used for the system installation
